Due to the present information warfare within the Northern California Territory, Sword of Fire will be utilizing our website library and media centers to establish an information command center for those within the Northern California Territory to understand the mission objectives and purposes of SOFAOL.

SOFAOL (Sword of Fire, Armour of Light) would like to create an awareness of our ministry or church’s organizational goals. The purpose of the command center is to inform those within the Nor-Cal Territory as well as those allied with us, of any and all significant developments that may affect them.

Additionally, to promote the activities of the ministry organization that may increase their effectiveness as ambassadors of Christ. Lastly, we want to keep all parties informed about any relevant internal information regarding SOFAOL and the Northern California Territory.

Our goals within this territory have yet to fully blossom and project forward. Now, with as much that lieth within us we must advance the purpose and mission of The Kingdom of God through all available means to bring forth that which we have been charged.

One thing that is absent from this territory is a flow of information occurring within this territory, as well as a response to the events happening which threaten the people of this territory, as well as the larger population of the United States of America.

For example, ON the 12th of February 2004, the mayor of San Francisco, CA. openly challenged the laws of California, openly challenged the laws of The

United States of America, and began to issue marriage licenses to gay and lesbian couples.

Within two days 2100 + licenses had been issued and there were lines around City Hall of persons from every quarter of the world who had flown, drove and centered their attentions upon the City of San Francisco, CA.

City Hall was opened on Saturday, Sunday and on a Holiday (Presidents Day) illegally & unlawfully marrying same sex couples. Within four days of 12 Feb 04 "The City" had added \$200,000 to the treasury as a result of the mass numbers of weddings licenses and weddings performed.

All of this began when two women aged 79 and 83 were "hurriedly issued a marriage license" in a private ceremony officiated by none other than the City Assessor, Mabel Teng.

In the name of "justice", Mayor Gavin Newsom subjected the City of San Francisco and all its citizens to the jurisdiction of laws foreign to the Constitution of the United States, and in violation of a citizen's ballot measure in which the majority of Californians approved, stating the definition of marriage as a union between a man and a woman.

Such arbitrary use of power is beyond a shadow of a doubt the commencing of tyranny.

The actions of Mayor Gavin Newsom point toward and confirm that any confidence in our judicial system and the laws of the United States of America, in addition to the laws of California, are no longer tenable.

What is most disturbing was the Contract of Silence from the Church of San Francisco, CA. With the exception of a few "conservative groups" from outside the City there was absolutely no voice from the Church to be heard.

Sword of Fire, Armour of Light has mailed a letter to the Mayor and the Board of Supervisors (the legislative branch of city government) condemning the unlawful actions of Mayor Newsom, and calling for an immediate cessation of this rebellious activity by our Executive Branch of Government.

Additionally, Sword of Fire is attempting to arrange a meeting within the Apostolic & Prophetic Leadership within the City to form a team effort that will

initiate an infrastructure for the future, as well as to have a more direct and more forceful response.

There has been one effort from one of the leaders in the city to march quietly around City Hall and pray. This we definitely agree with, however, we also believe that there is and should be a multi – level action plan implemented immediately.

Silence is only an encouragement to those who already desire to silence the voice and influence the Church of The Living God. Prayer should always work in congress or partnership with other measures.

Eventually, we believe there has to be a power encounter to dispel the works of darkness and societal madness coming forth from our city. For four decades the Church of San Francisco has maintained a de facto contract of silent complicity with the Powers of Darkness.

Silent encounters mean absolutely nothing to the enemies of God in this territory.

The question then becomes, why does the Church so adamantly oppose any visual or public response or confrontation?

Public action is clearly within the rule of constitutional law which endows every citizen of the United States of America the right to assemble.

With such a strong entrenched force of hell operating within this territory, it is my contention that there are human apostate agents at the highest level of leadership that are ensuring that no response is always the response of the Church of San Francisco, CA.
